A select group of Colorado lawyers are currently ABOTA members. ABOTA is an invitation-only organization consisting of lawyers who have tried a minimum of 20 civil jury trials to conclusion.

Recognized as a leader by his peers, Mr. Montoya was inducted into the International Society of Barristers in 2002 and recently named to the Board of Governors. Only a handful of attorneys throughout the United States are nominated and elected into this national society each year. As a member of the Society, Mr. Montoya joins an exclusive list of preeminent attorneys in the country. He also became a member of the International Society of Defense Counsel in 1997 and has been on the teaching faculty for the National Institute of Trial Advocacy (NITA) for over ten years.

Mr. Montoya is also AV certified with Martindale-Hubbell.
