### **Representative Matters**

- Obtained a \$10 million settlement in a commercial dispute involving copyright infringement on behalf of a leading national corporation against the largest clothing retailer in the US.
- Won a \$1.5 million verdict at trial in a commercial dispute between multiple corporations and shareholders regarding stock disputes and ownership rights.
